Daily Report



Summary

- Trade war and emerging markets continued to fret investors
- The sentiment on developed economies' stock markets remained sour
- Oil prices fell
- The breakdown of Hungary's GDP data reveals that growth was driven by investment and consumption

On balance, negative sentiment ruled Wednesday's trading on equity markets. There are two developments that keep investors anxious these days. First, President Trump's plan to implement today the latest round of tariffs on Chinese goods worth USD 200 billion has reignited trade war fears. Second, the risk aversion caused by the mounting problems of Turkey and Argentina (soaring inflation, collapsing currency, high debt levels, huge budget deficits) adversely affect the rest of the emerging world.

This tension left its mark on US stock markets. The S&P 500 dropped 0.3%, and the NASDAQ100 closed 1.3% in the red, dragged down by the technology sector's sharp fall.

In Europe's stock markets, Milan's FTSE MIB was the strongest performer even if it closed 0.1% down yesterday. Meanwhile, Germany's DAX (-1.4%) and France's CAC40 (-1.5%) fell. So did Britain's FTSE 100 (-1.0%) despite reports that Britain and the EU are moving toward a Brexit deal.

In Wednesday's supportive sentiment, the BUX climbed 0.2% higher. This made it the best performer in the CEE region, where Poland's WIG20 dropped 0.3%, and Prague's PX slumped 0.7%. The BUX's good performance owes a lot to OTP's 0.9% rally and MOL's 1.0% gain, even is the other two blue chips, Richter (-1.7%) and MTelekom (-1.0%) suffered losses.

Today the ÁKK will auction HUF 30 billion government debt in 12M zero-coupon treasury shares, and sell HUF 6 billion in 5Y government bonds. Yields on 5Y and 10Y government securities rose by six basis points yesterday.

Asia's markets extended a losing streak yesterday. Japan's Nikkei225 dropped 0.4%, while Hong Kong's Hang Seng was 1.5% in the red before the close. China's Shanghai Composite was seen 0.5% lower ahead of the close.

The US dollar did not do well on Wednesday, when the euro regained 0.5% lost ground from it. Even though the EUR/HUF made a short visit above 329, the forint firmed 0.1% at the end of the day. The Turkish lira shed 0.3% versus the EUR. The Argentine peso strengthened 1.0% against the USD. The USD/JPY stagnated.

Oil prices dropped yesterday. The Brent fell 1.2% and the WTI slid 1.7%. Precious metals' market had a quiet trading day. Silver price upped 0.3% and gold rose 0.2% only, despite investors' mounting worries. Industrial metal prices were mostly stable. Copper upped 0.3%.

Hungary released detailed GDP data yesterday. The 4.6% year/year growth rate surpassed expectations as did the 1.0% month/month expansion. Hungary's economic growth benefited from the good performance of the household final consumption expenditure and the rapid growth in investment.

As expected, the national bank of Poland left its base rate at 1.5% yesterday.

The German industrial orders figures published this morning were disappointing: they shrank by 0.9% as opposed to the expected 1.8% month/month expansion.

Today Hungary will release preliminary industrial production figures. A string of data is due out in the USA. The ADP institute will publish non-farm employment change. Factory orders and the ISM non-manufacturing statistics will also see the light of day.
