**A** / '**Politically exposed person**' shall mean a natural person who is entrusted with prominent public functions, or who has been entrusted with prominent public functions within one year before.

b)	member of parliaments or of similar legislative bodies
C)	member of the governing bodies of political parties;
d)	member of supreme courts, of the constitutional court or of other high-level judicial bodies, the
	decisions of which are not subject to further appeal;
e)	member of court of state auditors or of the board of central bank;
f)	ambassador, chargés d'affaires, high-ranking officers in the armed forces,
g)	member of the administrative, management or supervisory bodies of State-owned enterprises

h)	director, deputy director and member of the board or equivalent function of an international
	organisation

#### C/ Person being a close associate of the politically exposed person:

a)	any natural person who is known to have joint beneficial ownership of legal entities or unincorporated organizations, or any other close business relations, with a natural person
	who has been entrusted with prominent public functions
b)	any natural person who has sole beneficial ownership of a legal entity or unincorporated organization which is known to have been set up for the benefit of person who has been entrusted with prominent public functions.

I understand that during the existence of contractual relationship I shall notify the Bank on any changes concerning the politically exposed person status, within five (5) working days from notice.
