- ✓ If in two during the past three months (between the 16th of the third month and the 15th of the month immediately before a given monthly closing day) the daily average closing balance of all savings (term deposits, securities account (portfolio at valuation price), Foreign Currency Account (at daily average exchange rates), Long-term Investment Accounts, Long-term Investment Securities Accounts (portfolio at valuation price) Pension Savings Accounts (portfolio at valuation price), savings accounts linked to the account) of the Account Holder held with OTP Bank exceeded HUF 7.5 million, or

- ✓ If in two of the last three months prior to the monthly review (between the 16th of the third month and the 15th of the month prior to the given monthly closing day), net income of minimum HUF 500,000 is transferred to the account and/or to the Foreign Currency Accounts for which the Base Account with Premium services is specified as the nominated account.

When the Premium service is requested, a preferential monthly fee will be charged for the first 3 (full) months irrespective of the fulfillment of the conditions.
