✓ If in two during the past four months prior to the monthly review (between the 16th of the fourth month and the 15th of the month prior to the given monthly closing day), (a) an income equivalent to at least the net minimum wage is credited on the account and/or to the Smart Foreign Currency Account under the age of 35 (b) net income of minimum HUF 150,000 is transferred to the account and/or to the Foreign Currency Account over the age of 35. If the conditions of the preferential account management are not met, the normal account management fee will be charged.

When the Smart Account Package is requested, a preferential monthly fee will be charged for the first 4 (full) months irrespective of the fulfillment of the conditions.
